RESOLUTION RECOMMENDING AWARD OF THE CONTRACT TO CENTER STAGE PRODUCTIONS CO. FOR THE FILM PRODUCTION SERVICES ON THE PIA-DENR CLIMATE CHANGE CAMPAIGN

WHEREAS, the Philippine Information Agency through its Bids and Awards Committee (BAC) caused the advertisement of the Invitation to Bid (ITB) for the Film Production Services on the PIA-DENR Climate Change Campaign on April 10, 2014 through the Philippine Government Electronic Procurement System Website (PhilGEPS) and its agency website, www.pia.gov.ph, for fourteen (14) calendar days;

WHEREAS, in response to said ITB, one (1) agency attended the Pre-bid Conference which was held on April 21, 2014 at the PIA Conference Room, namely: Big Big Bang.

WHEREAS, on May 12, 2014, the evaluation of the technical and financial proposals of the bidders was done observing Rule IX - Bid Evaluation of the Revised IRR of R.A. 9184.

WHEREAS, on the same date, it was found out that two (2) agencies submitted their bids, namely: Center Stage Productions Co. and Ambient Lightpost Inc.

WHEREAS, the technical evaluation revealed that Center Stage Productions Co. was the sole bidder that was able to comply with all the requirements set forth by the Bid Data Sheet and the bidding documents. Ambient Lightpost Inc. was disqualified during said evaluation.

WHEREAS, the evaluation of the financial proposal revealed that Center Stage Productions Co. placed the single calculated responsive bid in the amount of **TEN MILLION FIVE HUNDRED THOUSAND PESOS (Php 10,500,000.00)** inclusive of VAT for the said project.

WHEREAS, Sec. 36. Single Responsive Bid Submission of the Revised IRR of R.A. 9184, states that:

“A single calculated/rated and responsive bid shall be considered for award if it falls under any of the following circumstances:

x x x

b. If after advertisement, more than one prospective bidder submits an LOI and/or applies for eligibility check, in accordance with the provisions of this IRR, but only one bidder meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements;

x x x”

WHEREAS, the remaining post-qualification requirements were submitted by Center Stage Productions Co. on May 20, 2014 in compliance to the Notice of Single Calculated Responsive Bid issued by the PIA BAC on May 12, 2014;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the Bids and Awards Committee, by virtue of the powers vested upon us by law, hereby RESOLVE to declare, as WE declare Center Stage Productions Co. as the single calculated responsive bid for the Film Production Services on the PIA-DENR Climate Change Campaign. WE further recommend the award of the contract for the said project to Center Stage Productions Co.

This resolution shall take effect immediately.
