**RESOLUTION RECOMMENDING AWARD OF THE CONTRACT TO VIBAL GROUP INC. FOR THE MOBILE APP DEVELOPMENT & MANAGEMENT SERVICES ON THE PIA-DENR CLIMATE CHANGE CAMPAIGN**

**WHEREAS**, the Philippine Information Agency through its Bids and Awards Committee (BAC) caused the advertisement of the Invitation to Bid (ITB) for the Mobile App Development & Management Services on the PIA-DENR Climate Campaign on June 14, 2014 through the Philippine Government Electronic Procurement System Website (PhilGEPS) and its agency website, [www.pia.gov.ph](http://www.pia.gov.ph), for fourteen (14) calendar days.

**WHEREAS**, in response to said ITB, one (1) agency attended the Pre-bid Conference which was held on June 26, 2014 at the PIA Conference Room, namely: Vibal Group.

**WHEREAS**, on July 15, 2014, the evaluation of the technical and financial proposals of the bidders was done observing Rule IX - Bid Evaluation of the Revised IRR of R.A. 9184.

**WHEREAS**, during the quality-cost evaluation, Vibal Group Inc. was able to comply with all the requirements set forth in the bidding documents and had the highest rated bid among the voting members of the BAC.

**WHEREAS**, the evaluation of the financial proposal revealed that Vibal Group Inc. quoted the amount of **SEVEN HUNDRED SEVENTY SEVEN THOUSAND SEVEN HUNDRED SEVENTY SEVEN PESOS (Php 777,777.00)** inclusive of VAT for the said project.

**WHEREAS**, the remaining post-qualification requirements were submitted by Vibal Group Inc. on July 17, 2014 in compliance to the Notice of Highest Rated and Responsive Bid issued by the PIA BAC on July 17, 2014;

**NOW, THEREFORE**, for and in consideration of the foregoing, WE, the members of the Bids and Awards Committee, by virtue of the powers vested upon us by law, hereby RESOLVE to declare, as WE declare Vibal Group Inc. as the highest rated and responsive bid for the Mobile App Development & Management Services on the PIA-DENR Climate Change Campaign. WE further recommend the award of the contract for the said project to Vibal Group Inc.

This resolution shall take effect immediately.
