**INVITATION TO BID
FOR BILLBOARD SITE RENTAL**


1. The Philippine Information Agency (PIA) intends to apply the sum of **THREE MILLION SEVEN HUNDRED THOUSAND PESOS (Php3,700,000.00)** being the Approved Budget for the Contract (ABC) as payment under the contract Billboard Site Rental with the Social Security System (SSS) project. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PIA now invites bids for the following requirements:
 - 4 sites in strategic locations, as follows:
 - NAIA going to pre-departure areas
 - Cebu - airport going to pre-departure areas
 - Davao - airport going to pre-departure areas
 - Clark - airport going to pre-departure areas
 - Size: 50ft x 80ft or bigger for each sites
 - Single face, billboard facing the traffic
 - Approximate daily traffic count per site:
 - 120,000 vehicles and above
 - Ensure availability of site at the time of contract signing
 - Duration: minimum of 3 months upon contract signing
 - Cost inclusive of production and installation fees
 - Bidders should show proof of ownership or lease of contract for each locations
 - Bidders that can give more visible location, bigger billboard sizes, and longer duration offer costs advantageous to the government.
3. Delivery of Goods is required within a period of three (3) months upon approval of Notice to Proceed. Bidders should have completed from the date of submission and receipt of bids a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in **Section II. Instructions to Bidders**.
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
6. Interested Bidders may obtain a complete set of Bidding Documents starting **May 27, 2016 to June 17, 2016** upon payment of a non-refundable fee in the amount of **Three Thousand Pesos (Php3,000.00)** from the PIA Cashier Section, 3F PIA Central Office, Visayas Avenue, Diliman, Quezon City.

7. The PIA will hold a Pre-Bid Conference open to all interested parties on **June 6, 2016** at **9:30a.m** to be held at the 3F Conference Room PIA Central Office, Visayas Avenue, Diliman, Quezon City.
8. Bids must be delivered to the PIA, BAC Secretariat, 2F Administrative Division, PIA Central Office, Visayas Avenue, Diliman, Quezon City on or before **June 17, 2016 at 12:00n**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Late bids shall not be accepted.

Bid opening shall be **June 17, 2016 at 1:30p.m.**, the venue will be held at the 3F Conference Room, PIA Central Office, Visayas Avenue, Diliman, Quezon City. Bids will be opened in the presence of the Bidders' representatives who choose to attend.
9. The Bids and Awards Committee of the Philippine Information Agency reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract awards, without thereby incurring any liability to the affected bidder or bidders.
