## INVITATION TO BID FOR TVC PRODUCTION ON THE DENR CLIMATE CHANGE CAMPAIGN

1. The Philippine Information Agency (PIA) intends to apply the sum of **ONE MILLION THREE HUNDRED FIFTY THOUSAND PESOS (Php 1,350,000.00)** being the Approved Budget for the Contract (ABC) as payment under the contract for the TVC Production Services as part of its Climate Change project with the Department of Environment and Natural Resources (DENR). Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PIA now invites bids for the following:
  - a) One (1) TVC 30's with edit down to TVC 15's; and
  - b) One (1) TVC 15's (on Mobile Apps).

Delivery of the Goods shall be determined during the Pre-Bid Conference. Bidders should have completed, within two years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested Bidders may obtain a complete set of Bidding Documents starting **Apr. 16, 2014 to May 05, 2014** upon payment of a non-refundable fee in the amount of **One Thousand Pesos (P 1,000.00)** from the PIA Cashier Section, 3F PIA Central Office, Visayas Avenue, Quezon City.

5. The PIA will hold a Pre-Bid Conference open to all interested parties on **Apr. 23, 2014, 10:00 A.M.** at the 3F Conference Room, PIA Central Office Bldg., Visayas Avenue, Quezon City.

6. Bids must be delivered to the PIA, BAC Secretariat, 2F Administrative Division, PIA Central Office Bldg., Visayas Avenue, Quezon City, on or before **May 05, 2014, 12:00 P.M.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Late bids shall not be accepted.

Bid opening shall be on **May 05, 2014, 1:30 P.M.** at the 3F Conference Room, PIA Central Office Bldg., Visayas Avenue, Quezon City. Bids will be opened in the presence of the Bidders' representatives who choose to attend.

7. The Bids and Awards Committee of the Philippine Information Agency reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
